Thank you for your request for environmental information. We appreciate your interest, and we want to let you know that your request has been carefully considered in accordance with the Environmental Information Regulations (EIR).

## Your request

Can you share the last water resiliency report that was carried out to show how the company was using the many thousands of new water bill payers due to the growth in housing in the region. Given the record rainfall the previous 18 months, what can united utilities show as evidence they did to proactively manage this record rainfall to ensure that the northwest was ready for a dry period?

## Our response

The WRMP includes a wide range of documents, from a high-level customer summary through to detailed technical appendices (for example, assessing the impact of population growth on demand). We update the WRMP every five years; the current version was published at the end of 2024, and we are now in the first year of delivering it. A key purpose of the plan is to identify and secure the investment needed for the future.

Ultimately our water supply system is designed so that the chance of needing to implement emergency restrictions (such as standpipes or rota cuts) is 1 in 200 in any given year. We describe this as "drought level 4". This year has been very dry, and we briefly entered drought level 2 before conditions improved due to increased rainfall in June. As set out in the WRMP, from 2039 our resilience will be increased so that the annual risk of emergency restrictions reduces to 1 in 500. Our approach to managing periods of low rainfall, including the use of drought levels, is set out in our Drought Plan, available here:

The drought plan is also updated every five years. The current version was published in 2022, and while we are following it now, we are already developing the 2027 plan and building in lessons learned from this year.
