- 3. Annual employee turnover (%) or retention rate (%)
- 4. Total health & safety incidents, including RIDDOR per 1,000 staff

As of FY25, there are approximately 6793 full time employees working at United Utilities. Please see the below table which shows how roles are split within the Company.

# 3. Annual employee turnover (%) or retention rate (%)

The average retention rate for United Utilities employees during FY25 is 97.90%.

# 4. Total health & safety incidents, including RIDDOR per 1,000 staff

Our colleague RIDDOR injury frequency rate for FY25 was 0.078 per 100,000 hours worked, which is a 15% improvement to FY24, amounting to 11 injuries within the year. You can read more about this on page 80 of the <u>United Utilities Integrated Annual Report 2025 (2).pdf</u>.
