This Supplementary Offering Circular (the “**Supplement**”) to the Offering Circular dated 21 November 2023 (the “**Offering Circular**”, which definition includes the Offering Circular as supplemented, amended or updated from time to time and includes all information incorporated by reference therein) which constitutes a base prospectus for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law in the United Kingdom by virtue of the European Union (Withdrawal) Act 2018, as amended (the “**UK Prospectus Regulation**”), constitutes a supplementary prospectus for the purposes of section 87G of the Financial Services and Markets Act 2000 and is prepared in connection with the GBP 10,000,000,000 Euro Medium Term Note Programme (the “**Programme**”) established by United Utilities PLC (“**UU**”) and United Utilities Water Finance PLC (“**UUWF**”) (each an “**Issuer**” and together the “**Issuers**”). The payment of all amounts due in respect of Notes issued by UUWF will be unconditionally and irrevocably guaranteed by United Utilities Water Limited (“**Uuw**” or the “**Guarantor**”).

This Supplement is supplemental to, forms part of, and should be read in conjunction with, the Offering Circular and any other supplements to the Offering Circular issued by the Issuers. Except as otherwise provided in this Supplement, terms and expressions defined in the Offering Circular shall have the same meaning when used herein.

Each of the Issuers and the Guarantor (together, the “**Responsible Persons**”) accepts responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Responsible Persons the information contained in this Supplement is in accordance with the facts and this Supplement does not omit anything likely to affect the import of such information.

Neither this Supplement nor any other information supplied in connection with the Programme or the issue of any Notes constitutes an offer or invitation by or on behalf of the Issuers, the Guarantor, any of the Dealers or the Trustee to any person to subscribe for or to purchase any Notes.

This Supplement has been approved by the FCA, as competent authority for the purposes of the UK Prospectus Regulation, as a supplement to the Offering Circular.

1. Purpose

The purpose of this Supplement is to:

- (A) incorporate by reference pages 1 – 47 (inclusive) of the full year results announcement for the year ended 31 March 2024 for United Utilities Group PLC (“UUG”) (“**UUG’s Full Year Results Announcement**”);
- (B) supplement the section entitled “Risk Factors” on pages 14 – 31 (inclusive) of the Offering Circular by incorporating by reference the narrative appearing under the title “*Principal risks and uncertainties*” on pages 22 – 27 of UUG’s Full Year Results Announcement;
- (C) update the Offering Circular to reflect certain changes to the board of directors of UUG;
- (D) update the “no significant change” statement in the Offering Circular; and
- (E) update the “no material adverse change” statement in the Offering Circular.

4. Changes to the board of directors

4.1 Clare Hayward

Clare Hayward was appointed to the boards of directors of UUG and UUG with effect from 16 April 2024. The list of directors of UUG on page 144 of the Offering Circular shall be updated

by the inclusion of a new row with 'Name' 'Clare Hayward' and 'Function' 'Independent Non-Executive Director'.

4.2 Paulette Rowe

Paulette Rowe will resign from the boards of directors of UUW and UUG as of 19 July 2024. Thereafter, the list of directors of UUW on page 144 of the Offering Circular shall be updated by the deletion of Paulette Rowe's row.

5. No significant change statement

There has been no significant change in the financial position or financial performance of each of UU, UUWF and UUW since the date of their respective last published audited annual financial statements, being 31 March 2023.

6. No material adverse change statement

There has been no material adverse change in the prospects of each of UU, UUWF and UUW since the date of their respective last published audited annual financial statements, being 31 March 2023.

7. General

Save as disclosed in this Supplement there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Offering Circular since the publication of the Offering Circular.
