## **General Eligibility Criteria**

General	Copies of company audited accounts, annual financial statements or income report,
eligibility	articles of association or similar documentation, for the relevant period, to
criteria	demonstrate that the organisation:

	<ul> <li>does not exist for commercial reasons; and,</li> </ul>
	<ul> <li>its shareholders, trustees, or others do not benefit financially from its activities; and,</li> </ul>
	<ul> <li>does not receive funding from the government or local authority.</li> </ul>
